RoHS Directive (Restriction of Harmful Substances)

SENECA S.r.I. complies with the criteria required by the European Union ROHS2 Directive (2011/65/EC), as it applies restrictions on certain hazardous substances in electrical and electronic equipment provided. The materials and finishing of the products do not exceed the acceptable levels set for the concentration of Cadmium, Mercury, Lead, Hexavalent chromium, Polybrominated biphenyls (PBB), Polybrominated Diphenyl Ethers (PBDEs), Nitrobenzene, 2,4-ditert-butyl-6-(5-chlorobenzotriazol-2-yl)phenol (UV-327), 2-(2H-benzotriazol-2-yl)-4-(tert-butyl)-6-(sec-butyl)phenol (UV-350), 1,3-propanesultone, Perfluorononan-1-oic-acid and its sodium and ammonium saltspropanesultone.
